## CMH obtains licenses for Home Show retail outlets

CHARLESTON -- State regulators approved new licenses in March for 11 manufactured housing retail locations previously owned by The Home Show of Hurricane.

The West Virginia Manufactured Housing Construction and Safety Standards Board (State Board) also approved a change of corporate name to Champion Home Builders Inc. for four out-of-state manufacturing plants.

Acting on a number of separate disciplinary issues, the State Board told 11 unlicensed companies to halt operations in West Virginia and imposed thousands of dollars in fines on others.

CMH Homes, Inc., of Maryville, TN, "bought out all The Home Shows, effective April 1," said Mitch Woodrum, director of the manufactured housing section of the West Virginia Division of Labor.

The eight West Virginia and three Kentucky locations of The Home Show were owned by Steve and Pam Brown on Hurricane. Steve Brown also was co-president of the industry trade association, the West Virginia Housing Institute Inc.

## 2010 convention July 20-21 in Charleston

CHARLESTON – Joe Stegmayer, head of Cavco Industries, and the new owner of Fleetwood Homes, is the keynote speaker at the WVHI convention July 20-21 in Charleston.

At least four of 14 board seats will be vacant when the statewide convention is gaveled to order July 21 at The Embassy Suites Hotel in Charleston. Ten people have filed their candidacies and more are expected.

Phoenix-based Cavco recently purchased Fleetwood Homes, which has a plant at Rocky Mount, Va., after the Riverside, Calif.-based, Fleetwood filed for Chapter 11 bankruptcy protection last year.

Cavco, which began operations in 1965, is one of the largest producers of manufactured housing in the country. It employs 600 people in two manufacturing plants in the Phoenix area and one in Texas.

Involved in the Fleetwood deal were facilities and 700 people in seven states.

Stegmayer, who addresses the banquet dinner July 21, leads off the list of educational speakers attendees at WVHI conventions have come to expect.

General Counsel John Teare and Associate General Counsel Johnnie Brown, both Charleston lawyers, will head a two-hour panel discussion and Q-and-A session to open the convention at 3 p.m. July 20.

After the lawyers' forum, attendees will visit nearby Appalachian Power Park for a game of baseball on a magnificently manicured lawn.

## WVHI acts for financial integrity

CHARLESTON -- Faced with a continued drop in revenue, a decision has been made to maintain the financial integrity of the industry's trade association.

The board of directors of the West Virginia Housing Institute Inc. has voted to increase dues by \$50-a-floor. The change is effective July 1.

The increase to \$100-a-floor matches similar increases in Maryland and Tennessee and other nearby states.

WVHI has been one of the more active and successful association in the country. It won an antidiscrimination law, exemption from the SAFE Act, infused new industry membership on the state regulatory board, among several things it has been able to accomplish.

WVHI has drastically trimmed its budget, cut the office staff and reduced expenditures to the bare minimum to counteract falling revenue, said Executive Director Andy Gallagher.

"We have not been forced to make a fee change for more than 20 years, which is unprecedented," Gallagher said. "The board determined this action was necessary before WVHI's reserves were exhausted."

# Industry News

## SAFE Act changes in West Virginia OK

CHARLESTON — Legislation to preclude manufactured and modular housing staff from having to become licensed mortgage brokers was revived this year by the West Virginia Legislature.

But the administration of Gov. Joe Manchin did nothing to weaken the exemption negotiated on behalf of the industry last year.

That exemption says sales staff do not have to undergo the extensive testing and licensing under the act.

"As always, we appreciate Governor Manchin's support in this important area for us," said WVHI Co-President Kevin Wilfong of Fairmont.

## February Shipments Improve by 6

CHARLESTON — Manufactured housing shipments improved slightly in February in West Virginia when compared to February 2009.

Floor shipments for this February totaled 71 in the state, while shipments of 66 floors were reported for the same period last year.

"It is not as much as I would like, but it is better than the alternative," said WVHI Co-President Kevin Wilfong of Fairmont.

January shipments were down 6.3 percent when compared to 2009.

*State Board from p. 1* Brown, who helped found WVHI, has resigned as a board member and co-president.

Champion Enterprises Holding, LLC, of Troy, MI, announced earlier this month it injected \$50 million into manufactured housing manufacturing company Champion Enterprises, Inc., to take it out of bankruptcy.

The State Board approved the following changes of names to Champion Home Builders Inc.: Atlantic Home Division, Claysburg, PA; Redman Homes, Ephrata, PA; New Era Building Systems, Strattonville, PA; and Redman in Topeka, IN.

The change was effective March 19, according to Woodrum.

The State Board levied fines of \$1,200 against two companies and reprimanded nine others in telling all 11 to cease operations in the state because they failed to obtain proper licenses.

The State Board fined 16 other companies \$3,700 for various infractions and cited more than 40 for failing to file quarterly reports to the DOL concerning their operations.

"We absolutely believe this was the only solution to the continued loss of funds," WVHI General Counsel John Teare said. "Other states are facing the same problem and are adopting the same solution."

"In order to maintain our presence, prevent encroachment on our successes and work for additional influence and advantages for our members, we have to adequately fund the organization to ensure its survival.

"All our members can recall times when our industry suffered regulatory and legislative setbacks when there was no one actively engaged and observing on a daily basis across multiple local and national groups, committees and regulatory agencies," Teare said.
